- 4. A copy of your dealers license and your dealer bond must be included.**
- 5. If you have an e-mail address be sure and include it on the form. Please print the e-mail address so it can be easily read. TNT notifies you the day before each auction, the amount of units available and when the unit pictures are posted for viewing on the Internet and any new information about the auction. If more than one individual would like to receive the e-mail you may write it next to or below your e-mail address.**
- 6. You must be registered with TNT in order to bid, even though you have a relationship with the selling dealer.**
